Abstract: A short abstract (not over 150 words) provides a concise outline of the scope, subject, and results of research. It should be written in English and in Serbian. **Key words:** To enable indexing, authors should add key words (3-7), also in English and Serbian languages (e.g. journal, instructions, papers, authors).

1. INTRODUCTION

"Šumarstvo" publishes scientific and professional papers, reports, and information on the achievements in forestry, wood processing, landscape architecture, and ecological engineering in soil and water resources protection. The journal is published in Serbian with Abstracts, Summaries and Tabular Views in English, four times a year. The submitted manuscript should be modelled according to the text of these Instructions.

2. HEADINGS (e.g. 2. MATERIAL AND METHODS)

Main headings are INTRODUCTION, MATERIAL AND METHODS, RESULTS, DISCUSSION (or RESULTS AND DISCUSSION), CONCLUSIONS and SUMMARY. Introduction presents the main guidelines of the paper, Material and Methods describe the applied techniques and methods. Results present the data obtained by the research, while Discussion relates the data to the already achieved results, i.e. with the potential further research. Conclusions, in addition to results, present the statements, attitudes, recommendations, etc. Summary (Rezime in Serbian) is a short recapitulation (not longer than one page) of the paper and it should be preceded by the Title and author(s) name(s) in Serbian.

3. HEADING (e.g. 3. RESULTS)

The manuscript is limited to ten pages of typewritten text, including the tables, diagrams, figures, References, etc. The wordprocessing package is MS WORD, if possible with option Tools \Rightarrow Options \Rightarrow Save \Rightarrow Embed TrueType fonts. Page set up of the manuscript should be 125×185 mm, the text is centred on paper size A4 (210×297 mm). Title is in bold script all capital letters, centred alignment, font size 12 pts. Headings are in bold capitals. Latin names should be typed in italic, body text font style regular, font size 10 pts. Literature citations in the text should be by author(s) and year of publication. Author's last name in text and literature is entered using the option: Format Font - Character Spacing - Spacing Expanded. (Karadžić, D., 1996), or by the author(s) in the sentence and year inserted in parentheses. Where there are more than

two authors, only the first should be named, followed by et al. (Mihajlović, Lj. et al., 1996).

4. HEADING (e.g. 4. DISCUSSION)

Tables and Figures contribute to better interpretation of the results, so double documentation of the same points in Figures and Tables is not acceptable. They can be processed in MS WORD or MS EXCEL. Captions should be in English and Serbian.

Manuscripts are submitted with inserted Tables and Figures (hardcopies in final printed version) in duplicate, and also in electronic form. Reports should be written according to instructions by "Komisija za sticanje naučnih zvanja Ministarstva za nauku i tehnološki razvoj Republike Srbije". Professional papers, depending on the consent by Editor-in-Chief, need not be in the above form. By respecting the above recommendations, you can exedite the publishing of your paper and improve the quality of the journal.
